

**Town of Summit
Monthly Meeting
November 12, 2013**

Ed Pfaff called the meeting to order at 7:00 P.M.

Roll Call: Ed Pfaff, Elaine Rollins, Jeff Hanson, Tammy Miller, Cory Wohlrab

Public Attendance: Pete Simon

Public Input: None.

Tammy Miller read the minutes of the October meeting. Jeff Hanson made a motion to accept the minutes as being read. Seconded by Cory Wohlrab. Motion carried.

Elaine Rollins gave the treasurer's report. A motion was made by Cory Wohlrab to accept the report as presented. Seconded by Jeff Hanson. Motion carried.

Building Permits: None.

Old Business: Ed attended another Mauston Ambulance meeting but there was only a brief discussion about the paramedic proposal. Ed invited the other members of the board to attend the next informational meeting.

New Business: Pete Simon was present to discuss the Seven Mile Creek recycling dumpster. He asked the town board if they would consider Seven Mile Creek placing a recycle dumpster at the Town Shop for his 8-10 people to be able to utilize. He explained the DNR minimum hour requirement for the recycling program. Pete feels they are wasting Township money for the few that use this service in their Township. Pete said they would be willing to pay a portion of the recycling personnel wages and pay for their own recycling dumpster pickup services. After Pete left the board further discussed this and agreed to make a motion. Jeff Hanson made a motion to take on Seven Mile Creek Recycling Dumpster at a cost of \$75 to them with contingency that they will have their own recycling dumpster picked up and contingent upon a written agreement. The motion was carried and approved by all saying Aye. Larry's health insurance premium has increased significantly so it has been decided that this payment will be increased to cover this amount for him. Pay increases for the patrolmen and yearend bonuses were also discussed. Jeff Hanson made a motion to increase payment for Larry's health insurance to \$500.00 a month, increase the patrolman wages \$.50 cents, and give yearend bonuses - \$300.00 for Larry Czys, \$50.00 for Clyde Keller, \$50.00 for Borden Buelow, and \$50.00 for Dennis Scott. Cory Wohlrab seconded the motion. Motion carried.

Road Maintenance: Sand has been delivered. Snow fence is being put up in different areas throughout the Township for experimenting.

Bills/Payments: Bills and payments were reviewed. Jeff Hanson made a motion to approve the bills as presented. Cory Wohlrab seconded the motion. Motion carried.

Motion to adjourn meeting at 8:17 P.M. was made by Cory Wohlrab. Seconded by Jeff Hanson. Motion carried.
