

**Town of Summit

December 13, 2011**

Jim Miller called the meeting to order at 7:02 P.M.

**Public Input:** Two members from the Wonewoc Fire dept. brought out a new truck they have purchased. The demonstration started about 8 minutes before the meeting which delayed the start of the meeting a couple minutes. They showed us the lighting system on the truck and opened all of the compartments to show all of the equipment that it can store. After the demonstration they came in to the Town Hall and Duane Tracy told us more about the truck. The truck is not new it is a 1994 E1 Heavy Rescue truck. They will take this truck to all calls. The truck was not purchased with the taxpayer's money. All of the money used to purchase this came from their fundraisers (like Chicken BBQ's, Hunter's Night Out etc.). The truck cost \$50,000 and they put \$10,000 worth of work in to it. A truck like this purchased new is \$550,000. Duane said they wanted to show it to all the municipalities and wanted to make sure that everyone was aware that it did not come out of their taxes. Also, they want the community to see how they use the fundraising money. Jim Miller thanked them for coming out and showing us this equipment.

Don Fry was concerned about the redistricting of the fire departments. Mauston was now his area and is 5 miles farther away than Wonewoc was. When he talked to 2 different people in Mauston they said that the Township was responsible for setting up the districts. Jeff Hanson explained to Don that we have been looking into the district situation for a while now because we were concerned about the fact that maybe there was an overlap too and we were overpaying each month to the fire departments. We have asked this also and no one seems to be able to give us an answer. Jeff went on to say that the Township has never been involved with establishing the districts nor have we been told that we need to do anything with it. The lengthy discussion ended with Jim Miller saying that he would look in to this when he attends the next ambulance meeting. He will talk to some people over in Mauston and try to get some answers.

Tammy Miller read the minutes of the November Budget and Elector Town Board meeting. Jeff Hanson made a motion to accept the minutes as being read. Seconded by Jim Miller. Motion carried. Tammy Miller also read the minutes of the November Monthly Board meeting. Jeff Hanson mad a motion to accept the minutes as being read. Seconded by Jim Miller. Motion carried.

Elaine Rollins gave the treasurer's report. A motion was made by Jeff Hanson to accept the report as presented. Seconded by Jim Miller. Motion carried.
