– Clyde is doing some ditching. Ed looked at a 3/4 ton truck that cost \$12,000 and could be used for plowing. Jim and Jeff both agreed that he should continue looking into it. The backhoe has front end problems so there was discussion about either fixing it or looking at trading it in. Jim, Jeff, and Ed all agreed that it should be sent out for an estimate as soon as they are done using it to see what it would cost to fix it. It also needs tires so that is an additional cost to add to it. Ed talked to Chris Ruhland about doing some part time plowing. Chris already has his CDL because he drives a dump truck and he has agreed to do this for us.

Bills/Payments were reviewed. Jeff Hanson made a motion to approve the bills as being presented. Jim Miller seconded the motion. Motion carried.
